IN MEMORIAM



APRIL M. MORTON (April 1988-December 2019) was a Research Scientist in the Geographic Data Sciences Group at Oak Ridge National Laboratory where she was also pursuing a PhD in Data Science and Engineering at the University of Tennessee under the leadership of Nicholas Nagle and Robert Stewart. At Oak Ridge, she was working to develop high-resolution, demographically detailed population models using machine learning techniques. April was the co-author of 30 papers and technical reports and held one patent. Prior to coming to Oak Ridge, April worked as a statistical analyst and research associate for Southern California Edison, Jet Propulsion Laboratory, and the University of Geneva in Switzerland. April talked frequently and excitedly about attending the 2020 SDA meeting, presenting a paper based on her dissertation work, and submitting for the Everett Lee paper award. She was looking forward to getting feedback on her work from population scientists. An avid and extensively experienced kayaker, she was killed in a boating accident on December 16, 2019 on the Big Laurel River in North Carolina. She was 31.

SDA Plenary Speaker 2022



Jennifer Karas Montez, PhD, is University Professor of Sociology and the Gerald B. Cramer Faculty Scholar in Aging Studies at Syracuse University. Her research focuses on trends and disparities in U.S. population health since the 1980s and the growing influence of state policies and politics on health. A major focus of this work investigates why health trends are particularly worrisome for women, for people without a college degree, and for those living in states in the South and Midwest. Currently, Montez is investigating the links between democratic backsliding at the state level and the deterioration of population health. Her research on these topics has been funded by the National Institute on Aging, Robert Wood Johnson Foundation, National Science Foundation, and an Andrew Carnegie Fellowship.

Montez directs the Center for Aging and Policy Studies, which is an NIA-funded consortium among three upstate New York universities (Syracuse, Cornell, University at Albany), and co-directs the NIA-funded national Network on Life Course Health Dynamics and Disparities. In addition, she co-directs the Policy, Place, and Population Health (P3H) Lab at Syracuse University to train graduate students and postdocs on how places and their policies shape population health. Montez recently served as Deputy Editor for Demography and currently serves on the editorial boards of *Journal of Health and Social Behavior* and *The Milbank Quarterly*, as well as the board of directors for the Population Association of America and Interdisciplinary Association for Population Health Science. Montez holds a Ph.D. in Sociology with a Demography Specialization from the University of Texas at Austin, M.A. in Sociology from the University of Houston, M.S. in Statistics from Purdue University, and B.S. in Mathematics from Purdue University.

Creating an Infrastructure to Modernize the Census Bureau's Statistical Foundation through Enterprise Frames

President: Jennifer M. Ortman, U.S. Census Bureau

The U.S. Census Bureau has long maintained frame-like data to support census and survey operations. A multitude of programs, censuses, and surveys across the Census Bureau collect, maintain, and provide universe-level information on individuals, households, businesses, and governments. However, these data are rarely used for enterprise-wide operations, despite abundant evidence of the value of integrating data to produce new and/or improved statistical products. There is a need for a modernized data infrastructure; a linked universe of information from which sampling can occur and statistical summaries directly produced. The Census Bureau has established the Frames Program to meet this need, with a focus on maximizing the utility of the Census Bureau's demographic, economic, and geospatial data while minimizing the data collection burden on households and businesses and addressing redundancies in Census Bureau data processing.

During this panel session, Census Bureau staff will summarize objectives and achievements of the nascent Frames Program, highlight the evolution of the existing Business, Job, and Geospatial Frames, detail efforts to establish a linkage infrastructure to better leverage these resources, and introduce the new enterprise frame: the Demographic Frame. An external expert will provide commentary on the development of the Frames Program and utility for Census Bureau programs and data operations.

Wesley James is entering his 14th year at the University of Memphis and currently serves as Professor of Sociology and Executive Director of the Center for Community Research and Evaluation (CCRE). He received his Ph.D. from Mississippi State University in 2009.

Dr. James' primary research interests are medical sociology, demography, and rural health. He has been the PI on numerous grants and contracts, primarily in the areas of health and education in the Mississippi Delta. Currently, his research agenda is focused in three areas: (1) U.S. mortality disparities across time and place, (2) social determinants of health and mortality in rural America, and (3) evaluating health and educational interventions in the Mississippi Delta.

Dr. James is an active member of the Southern Sociological Society (SSS), Population Association of America (PAA), and Southern Demographic Association (SDA). He is a member of the 2020 class of P.I. Millionaires at the University of Memphis, has been recognized with excellence in teaching as the 2013 recipient of the W. Russell Smith Award, the 2021 Pat E. Burlison Professor Award, and the 2022 Distinguished Researcher in the Social Sciences at the UofM. Dr. James has delivered talks on rural health around the nation, highlighted by invited presentations at a Congressional Briefing on Capitol Hill and at the National Cancer Institute. Dr. James has been published in American Journal of Public Health, Social Science and Medicine Population Health, Demographic Research, N-IUSSP, Population Research and Policy Review, Journal of Rural Health, and many others.

Rogelio Sáenz is Professor in the Department of Demography at the University of Texas at San Antonio (UTSA). He has held prior positions as Dean of the College of Public Policy at UTSA and Professor in the Department of Sociology at Texas A&M University. Sáenz received his Ph.D. and M.S. in sociology from Iowa State University and B.S.W. in social work from Pan American University. His research focuses on the intersection between demography, race, and inequality. Sáenz has written on a wide array of topics including migration, health disparities, labor market earnings, intermarriage, poverty, aging, public policy, and social justice. From the early days of the pandemic, he has written extensively on the impact of COVID-19 on Latinos and other racial and ethnic groups. Sáenz is co-author of *Latinos in the United States: Diversity and Change* and is co-editor of *International Handbook of the Demography of Race and Ethnicity*.

In addition to his scholarly research, Sáenz has written widely to the general public including op-ed essays and research briefs for a variety of media outlets throughout the country. He recently received the 2020 Saber es Poder Academic Excellence Award from the University of Arizona's Department of Mexican American Studies, the 2021 Cox-Johnson-Frazier Award from the American Sociological Association (ASA), and the 2022 Julian Samora Distinguished Career Award from the ASA Section on Latina/o Sociology. Sáenz was also inducted to the UTSA Academy of Distinguished Researchers in 2021. He was recently appointed to the Census Scientific Advisory Committee.

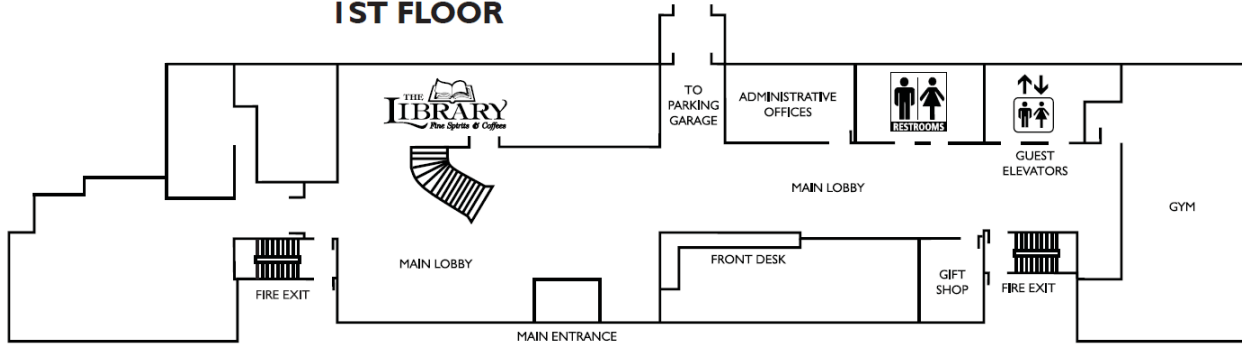
